Outside User Agreement:

The Temiskaming Nordic Ski Club (TNSC) facilities are available to community groups who participate in activities which respect the environment and promote the health of the community.

This agreement may be changed at the discretion of the executive of the TNSC. The executive reserves the right to cancel any agreement without prior notice.

Terms of the agreement:

1. Any group requesting the use of TNSC facilities must complete this form and present it to one of the executive of the TNSC, at least 7 days prior to the event date. _____
2. Once the request is approved, a copy of the form signed by both parties will be returned to the applicant. _____
3. The kitchen and kitchen equipment may be used, but must be left in their original condition or better. Groups must supply their own food, unless other arrangements have been made with TNSC executive. _____
4. The user group is responsible for cleaning the facility to its original condition at the end of the event. TNSC reserves the right to charge a clean-up fee if deemed necessary. _____
5. The user group must provide their own liability insurance coverage adding the Temiskaming Nordic Ski Club as an additional insured. A copy of the certificate of insurance listing TNSC must be provided prior to approval of the outside user request. _____
6. The TNSC, Cross Country Canada, or Canadian Snowsports Association shall not be held responsible for bodily injuries, damage, loss or theft of personal belongings or equipment during the use of its facilities. The user(s) agree to indemnify and hold harmless the TNSC, Cross Country Canada, Canadian Snowsports Association, and all private land owners within TNSC's trail system for any cause of action that should arise during the time the user(s) is in possession of the facilities. _____

Rules:

1. The person completing this form will be responsible for the behaviour of everyone admitted into the TNSC facilities and shall ensure that the physical environment is respected and that the neighborhood is not disturbed by inappropriate or loud activities.

2. The requestor will ensure that these terms are known and respected by all persons attending the event.
3. Alcohol may not be consumed in the TNSC facilities unless the TNSC executive has granted a special request and the user(s) have provided a copy of a liquor license specific to the rental space for the rental period stated. If so, provincial laws pertaining to the consumption of alcohol must be respected.
4. Smoking is strictly prohibited in the chalet.
5. Open fires are prohibited, unless the TNSC executive has granted a special request.
6. If an accident occurs during the event, it must be reported to the executive member authorizing this agreement.
